Allowable Hours: 30 minutes

Issue:

Genie has received reports of machine serial labels printed with incorrect "Machine Unladen Weight" value. The "Machine Unladen Weight" value printed on the serial label is significantly different from the actual machine weight. This can result in incorrect conclusions regarding the floor loading effects of the machine. **Incorrect floor loading information may result in the user operating the machine on a surface that is not capable of supporting the machine weight.**

This safety notice requires replacement of the serial label on all affected machines.

Continued Use Instructions:

All machine operators must be notified of these continued use requirements.

Machines may remain in service while waiting for the replacement serial label provided the surface the unit is being used on is capable of supporting a live load per the table below:

Note: The serial number printed on the serial label should be the same serial number stamped on the chassis of your machine.



- 2 Fill out the attached parts order form and return to Terex AWP Parts department to receive the new serial label with the correct "Machine Unladen Weight" value.

Note: The serial number of the affected machine is required on the parts order form.

- 3 Upon receipt of the new serial label, replace the one currently attached to your machine.

Installation of the new serial label must take place as soon as possible but no later than 30 days from receipt of the kit.

- 4 Fill out and sign the completion form included in the installation instructions in the kit and return to Terex AWP Warranty department to verify that this safety notice have been completed.
